AKTA PERBADANAN INSURANS DEPOSIT MALAYSIA 2011

PERINTAH PERBADANAN INSURANS DEPOSIT MALAYSIA (PREMIUM TAHUNAN DAN  
PREMIUM PERTAMA BERKENAAN DENGAN ANGGOTA PENERIMA DEPOSIT)  
(PINDAAN) 2012

PADA menjalankan kuasa yang diberikan oleh subseksyen 47(1), 48(2) dan 48(3) Akta Perbadanan Insurans Deposit Malaysia 2011 [*Akta 720*], Menteri, atas syor Perbadanan, membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Perbadanan Insurans Deposit Malaysia (Premium Tahunan dan Premium Pertama Berkenaan dengan Anggota Penerima Deposit)(Pindaan) 2012**.

(2) Perintah ini hendaklah berkuat kuasa mulai tahun taksiran 2013.

**Pindaan perenggan 2**

2. Perintah Perbadanan Insurans Deposit Malaysia (Premium Tahunan dan Premium Pertama Berkenaan dengan Anggota Penerima Deposit) 2011 [*P.U. (A) 28/2011*], yang disebut "Perintah ibu" dalam Perintah ini, dipinda dalam perenggan 2 dengan menggantikan subperenggan (1) dengan subperenggan yang berikut:

"(1) Tertakluk kepada perenggan 3 dan apabila kategori premium yang dalamnya suatu anggota penerima deposit dikelaskan bagi suatu tahun taksiran menurut Peraturan-Peraturan Perbadanan Insurans Deposit Malaysia (Sistem Premium Berbeza berkenaan dengan Anggota Penerima Deposit) 2011 [*P.U. (A) 34/2011*], adalah sebagaimana yang dinyatakan dalam Jadual Pertama, kadar premium tahunan yang kena dibayar oleh anggota penerima deposit itu adalah kadar premium bagi tahun taksiran yang dinyatakan dalam ruang (2), (3) atau (4) yang bersetentangan dengannya dalam Jadual Pertama."

**Pindaan Jadual Pertama**

3. Perintah ibu dipinda dengan menggantikan Jadual Pertama dengan Jadual yang berikut:

MALAYSIA DEPOSIT INSURANCE CORPORATION ACT 2011

MALAYSIA DEPOSIT INSURANCE CORPORATION (ANNUAL PREMIUM AND FIRST PREMIUM IN RESPECT OF DEPOSIT-TAKING MEMBERS) (AMENDMENT) ORDER 2012

IN exercise of the powers conferred by subsections 47(1), 48(2) and 48(3) of the Malaysia Deposit Insurance Corporation Act 2011 [*Act 720*], the Minister, on the recommendation of the Corporation, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Malaysia Deposit Insurance Corporation (Annual Premium and First Premium in Respect of Deposit-Taking Members) (Amendment) Order 2012**.

(2) This Order shall have effect from the assessment year of 2013.

**Amendment of paragraph 2**

2. The Malaysia Deposit Insurance Corporation (Annual Premium and First Premium in Respect of Deposit Taking Members) Order 2011 [*P.U. (A) 28/2011*], which is referred to as the “principal Order” in this Order, is amended in paragraph 2 by substituting for subparagraph (1) the following subparagraph:

“(1) Subject to paragraph 3 and where the premium category in which a deposit-taking member is classified for an assessment year pursuant to the Malaysia Deposit Insurance Corporation (Differential Premium Systems in respect of Deposit-Taking Members) Regulations 2011 [*P.U. (A) 34/2011*], is as specified in the First Schedule, the rate for the annual premium payable by such deposit-taking member shall be the corresponding premium rate for that assessment year specified in column (2), (3) or (4) of the First Schedule.”.

**Amendment of First Schedule**

3. The principal Order is amended by substituting for the First Schedule the following Schedule:
