PERATURAN-PERATURAN PERBADANAN INSURANS DEPOSIT MALAYSIA
(SISTEM PREMIUM BERBEZA BERKENAAN DENGAN ANGGOTA PENERIMA DEPOSIT)
(PINDAAN) 2014

PADA menjalankan kuasa yang diberikan oleh seksyen 53 Akta Perbadanan Insurans Deposit Malaysia 2011 [*Akta 720*], Perbadanan membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Perbadanan Insurans Deposit Malaysia (Sistem Premium Berbeza berkenaan dengan Anggota Penerima Deposit) (Pindaan) 2014**.

(2) Peraturan-Peraturan ini berkuat kuasa mulai tahun taksiran 2014.

Pindaan Jadual

2. Peraturan-Peraturan Perbadanan Insurans Deposit Malaysia (Sistem Premium Berbeza berkenaan dengan Anggota Penerima Deposit) 2011 [*P.U. (A) 34/2011*] dipinda dalam Jadual seperti yang berikut:

- (a) dengan menggantikan perkataan “nisbah modal berwajaran risiko” di mana-mana jua terdapat dengan perkataan “nisbah jumlah modal”;
- (b) dengan menggantikan perkataan “modal teras” di mana-mana jua terdapat dengan perkataan “modal Kumpulan 1”;
- (c) dengan menggantikan perkataan “nisbah modal teras” di mana-mana jua terdapat dengan perkataan “nisbah modal Kumpulan 1”; dan
- (d) dengan menggantikan perkataan “modal asas” di mana-mana jua terdapat dengan perkataan “jumlah modal”.

MALAYSIA DEPOSIT INSURANCE CORPORATION
(DIFFERENTIAL PREMIUM SYSTEMS IN RESPECT OF DEPOSIT-TAKING MEMBERS)
(AMENDMENT) REGULATIONS 2014

IN exercise of the powers conferred by section 53 of the Malaysia Deposit Insurance Corporation Act 2011 [*Act 720*], the Corporation makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Malaysia Deposit Insurance Corporation (Differential Premium Systems in respect of Deposit-Taking Members) (Amendment) Regulations 2014**.

(2) These Regulations have effect from the assessment year of 2014.

Amendment of the Schedule

2. The Malaysia Deposit Insurance Corporation (Differential Premium Systems in respect of Deposit-Taking Members) Regulations 2011 [*P.U. (A) 34/2011*] are amended in the Schedule as follows:

(a) by substituting for the words “risk-weighted capital ratio” wherever appearing the words “total capital ratio”;

(b) by substituting for the words “core capital” wherever appearing the words “Tier 1 capital”;

(c) by substituting for the words “core capital ratio” wherever appearing the words “Tier 1 capital ratio”; and

(d) by substituting for the words “capital base” wherever appearing the words “total capital”.
