

PIDM #JomKenaliPIDM' FACEBOOK WEEKLY QUIZ TERMS AND CONDITIONS

A) GENERAL

1. The #JomKenaliPIDM Facebook Weekly Quiz (the "Contest") is organised by Perbadanan Insurans Deposit Malaysia ("PIDM").
2. The Contest is open to all Malaysians aged eighteen (18) years old and above who reside in Malaysia and have a valid MyKad ("Participants").
3. The following groups of persons or Facebook accounts shall **not** be eligible to participate in the Contest:
 - (a) employees of PIDM and their immediate family members (namely parents, siblings, spouse and children);
 - (b) employees or agents of service providers (including its affiliated and related companies) appointed by PIDM to undertake the advertising, promotion or administration of the Contest and their immediate family members; or
 - (c) a company's or a firm's Facebook account or a group of persons who have a joint Facebook account.
4. The Contest will be governed by these terms and conditions as well as PIDM's Privacy Notice as set out at <https://www.pidm.gov.my/en/privacy-notice/> (collectively referred to as the "Terms"). By participating in the Contest and providing personal data, photographs and recordings to PIDM, each Participant is deemed to have read, understood, accepted and agreed to the Terms and to have irrevocably given express consent to PIDM to collect, use, store, process or disclose, without liability, such personal data, photographs and recordings for the purposes of the Contest and events related to the Contest, PIDM's activities and suggestions for improvement of PIDM's future activities, PIDM's publicity, research and data analytic purposes as well as for the purposes stated in PIDM's Privacy Notice. By participating in the Contest, each Participant agrees to be bound by the Terms and the decisions of PIDM on any matter in relation to the Contest. PIDM reserves the right to amend the Terms at its sole discretion without prior notice.
5. The Contest is held on PIDM's official Facebook page and is divided into three (3) periods as follows:
 - (a) #JomKenaliPIDM Week 1 will run for four (4) days from 1 December 2022 at 1.00PM to 4 December 2022 at 11.59PM following (UTC+08:00) Kuala Lumpur, Malaysia time zone ("Week 1");

- (b) #JomKenaliPIDM Week 2 will run for four (4) days from 8 December 2022 at 1.00PM to 11 December 2022 at 11.59PM following (UTC+08:00) Kuala Lumpur, Malaysia time zone (“Week 2”); and
- (c) #JomKenaliPIDM Week 3 will run for four (4) days from 15 December 2022 at 1.00PM to 18 December 2022 at 11.59PM following (UTC+08:00) Kuala Lumpur, Malaysia time zone (“Week 3”).

The contest periods for Week 1, Week 2 and Week 3 are collectively referred to as the “Contest Period”. PIDM reserves the right to amend the Contest Period at any time at PIDM’s sole and absolute discretion.

- 6. Participants do not need to pay any fee, charges or commission to any person in order to participate in the Contest.
- 7. This Contest is in no way sponsored, endorsed or administered by, or associated with Facebook.

B) WAYS TO PARTICIPATE

Week 1: ‘#JomKenaliPIDM’ Quiz (Submission Period: 1 December 2022 – 4 December 2022)

- 8. To participate in Week 1 of the Contest, a Participant is required to fulfill all of the steps and requirements set out below:

Step 1

Follow PIDM’s official Facebook page.

Step 2

“Like” the ‘#JomKenaliPIDM’ Facebook post posted on PIDM’s official Facebook page on 1 December 2022 (“Week 1 Contest Post”).

Step 3

Answer the two (2) questions set out under the Week 1 Contest Post, in the following manner:

- (a) provide the correct answers for the two (2) questions in the comments section of the Week 1 Contest Post;
- (b) tag three (3) friends and include the #JomKenaliPIDM hashtag along with the answers in the comments section of the Week 1 Contest Post; and
- (c) provide the answers or submission at the latest by 4 December 2022 at 11.59PM.

Week 2: '#JomKenaliPIDM' Quiz (Submission Period: 8 December 2022 – 11 December 2022)

9. To participate in Week 2 of the Contest, a Participant is required to fulfill all of the steps and requirements set out below:

Step 1

Follow PIDM's official Facebook page.

Step 2

"Like" the '#JomKenaliPIDM' Facebook post posted on PIDM's official Facebook page on 8 December 2022 ("Week 2 Contest Post").

Step 3

Answer the two (2) questions set out under the Week 2 Contest Post, in the following manner:

- (a) provide the correct answers for the two (2) questions in the comments section of the Week 2 Contest Post;
- (b) tag three (3) friends and include the #JomKenaliPIDM hashtag along with the answers in the comments section of the Week 2 Post; and
- (c) provide the answers or submission at the latest by 11 December 2022 at 11.59PM.

Week 3: '#JomKenaliPIDM' Quiz (Submission Period: 15 December 2022 – 18 December 2022)

10. To participate in Week 3 of the Contest, a Participant is required to fulfill all of the steps and requirements set out below:

Step 1

Follow PIDM's official Facebook page.

Step 2

"Like" the '#JomKenaliPIDM' Facebook post posted on PIDM's official Facebook page on 15 December 2022 ("Week 3 Contest Post").

Step 3

Answer the two (2) questions set out under the Week 3 Contest Post, in the following manner:

- (a) provide the correct answers for the two (2) questions in the comments section of the Week 3 Contest Post;

- (b) tag three (3) friends and include the #JomKenaliPIDM hashtag along with the answers in the comments section of the Week 3 Post; and
 - (c) provide the answers or submission at the latest by 18 December 2022 at 11.59PM.
11. Each Participant is only entitled to submit one (1) Entry for each week of the Contest. All Entries must be submitted and posted through the Participant's own genuine personal Facebook account. Use or attempts to use more than one (1) Facebook account in order to participate in the Contest shall not be permitted. Each Entry must be in either Bahasa Malaysia or English language only and must be comprehensible by PIDM.

The term "Entry" or "Entries" whenever used in these Terms mean any submission by the Participant in relation to the Contest including but not limited to, the answers to the questions and comments on PIDM's official Facebook page.

12. Participants must submit their Entry by the respective deadlines for each week of the Contest Period as set out above in this Section B. Any Entry submitted outside of the respective deadlines will not be accepted. PIDM accepts no responsibilities for any Entries that are not processed or received for any reason, including any delay, interruption, failures or due to technical, hardware, software malfunction of any kind, unavailable network connections, communication lines, servers, or any combination thereof.
13. All Entries by the Participants must be complete and fulfil the steps and requirements for each week of the Contest Period as set out above in this Section B. Any Entry that is incomplete or does not adhere to the specified deadline will automatically be disqualified.

C) PRIZES

14. The Prizes and number of winners are as follows:
- (a) Week 1: RM30 Lazada Cash Voucher x ten (10) winners
 - (b) Week 2: RM30 Lazada Cash Voucher x ten (10) winners
 - (c) Week 3: RM30 Lazada Cash Voucher x ten (10) winners
15. Participants are entitled to participate in each week of the Contest. However, each eligible winner (as identified by MyKad number) shall only be entitled to one (1) Prize throughout the whole Contest.
16. Prizes will be sent to the winners via Facebook Messenger Private Message ("PM") by 31 January 2023. Any other delivery mode or prize redemption is not available.

17. All prizes are non-transferable and are not exchangeable or redeemable for cash or any other alternatives. PIDM reserves the right, at any time, at its sole and absolute discretion and without the need to provide prior notice to the winners, to substitute the prize with another of equivalent or higher value. PIDM shall not be liable in any way with regards to the adequacy, the quality or the suitability of the prizes offered.

D) SELECTION OF WINNERS

18. Ten (10) winners will be chosen for each week of the Contest Period, to win a Lazada Cash Voucher of RM30 for each winner.
19. For each week of the Contest Period, PIDM will select the first ten (10) winners from amongst Participants who answer the questions correctly and fulfill all of the participation criteria for that week of the Contest Period as set out in Section B above. If the answers given for an Entry is correct but is simply a copy of a previous correct answer, PIDM has the discretion to only accept the first and original submission and reject any other Entry that is a copy of the first and original submission. PIDM reserves the right to determine whether an Entry is a copy.
20. In determining whether an Entry is valid, PIDM will take into account all factors deemed relevant by PIDM, which may include, but shall not be limited to, the following criteria:-
 - (a) the Entry needs to be original and not a material of duplication, copy or reproduction of other Entries; and
 - (b) the Entry is not offensive, illegal or insensitive to any segment of society, etc.
21. PIDM will inspect and filter each Entry submitted by Participants to ensure compliance with the requirements above. PIDM reserves the right, at its sole discretion, to remove, reject or disqualify an Entry if it finds the Entry to be violating any of the Terms or any applicable laws or regulation.
22. PIDM's decisions on all matters relating to the Contest shall be final and binding, and no appeal or correspondence in any form will be entertained by PIDM. Participants shall not dispute nor make any oral or written complaints, public announcements, commentaries or statements on the Participant's dissatisfaction or otherwise, whether during or after the Contest Period.

E) WINNER ANNOUNCEMENT

23. The winner announcement will be made via comments on PIDM's official Facebook Page (<https://www.facebook.com/PerbadananInsuransDepositMalaysia/>) within two (2) weeks respectively of the submission deadline for each week of the Contest. Winners will be

mentioned under the '#JomKenaliPIDM' Contest post respectively for Week 1, Week 2 and Week 3.

24. Within one (1) week of each winner announcement, winners are required to send a Facebook PM to PIDM's official Facebook page and provide their personal particulars (name as per Mykad, MyKad number, handphone number and e-mail address) in order to claim their prize. Failure to send a PM to PIDM with the requisite information and within the stipulated response time as stated above will result in the withdrawal of the prize to such winner. PIDM shall not be held responsible for any loss (including loss of opportunity and any other associated losses) and damages suffered in the event the winner cannot be contacted, has delayed or failed to provide requisite information or comply with the Terms.

F) OTHER TERMS AND CONDITIONS

25. PIDM reserves the right to use the names, photographs and such other information of the Participants provided to PIDM as materials for the purposes of advertising and publicity ("Materials"), without the need to provide prior notice to the Participants. The Participants shall not be entitled to claim ownership or other forms of fee or compensation arising from or in relation to the Materials.
26. PIDM reserves the right to reject any Entry that is incorrect, incomplete, suspicious or invalid. Each Participant agrees not to knowingly damage or cause interruption to the Contest and/or prevent others from entering the Contest.
27. The Participants and the winners shall assume full liability and responsibility in the case of any loss, damage, proceedings, suits, liability, mishap, injury, damage, claim or accident (including death) resulting from their participation in the Contest or the redemption and utilisation of the prizes, including infringement of intellectual property rights or third party rights. The Participants and the winners agree to release and hold PIDM free and harmless of any liability whatsoever.
28. Each Participant warrants and represents, in respect of each Entry submitted, as follows:
 - (a) the Participant is the sole owner and author of each Entry;
 - (b) each Entry does not contain or suggest any non-original, infringing, threatening, false, misleading, abusive, harassing, libellous, defamatory, vulgar, obscene, scandalous, inflammatory, pornographic or profane content. PIDM reserves the right to determine whether an Entry contains such content;
 - (c) each Entry does not contain any content that could constitute or encourage conduct which would be considered a criminal offence, give rise to civil liability, or

otherwise violate any law. PIDM reserves the right to determine whether an Entry contains such content; and

- (d) each Entry does not infringe upon the copyrights, trademarks, contract rights, or any other intellectual property rights of any third person or entity, or violate any person's rights of privacy or publicity, and the Entry does not include any:
 - (i) trademark owned by third parties.
 - (ii) copyrighted material owned by third parties; and
 - (iii) commercial content that promotes any product or service other than that of PIDM.

PIDM reserves the right, in its sole discretion, to disqualify any Participant and to remove any image, video, comment or content that does not comply with the requirements or arising from a breach of the warranty or representation as set out in clause 28(a), (b), (c) or (d) above.

- 29. Any participation that breaches any of the Terms will automatically be disqualified without the need to provide prior notice to the Participant. PIDM has the right to determine whether a participation breaches the Terms or otherwise.
- 30. The Participants and the winners agree to indemnify PIDM on any loss or damage suffered by PIDM due to any non-compliance of the Terms by the Participants or the winners.
- 31. PIDM reserves the right to postpone or cancel the Contest or to modify the Terms or prizes at any time at its sole and absolute discretion. Any such modification shall be notified through PIDM's official Facebook Page. Such modifications shall be immediately effective and apply to all Entries, including Entries that have been submitted to PIDM.
- 32. These Terms are governed by and construed in accordance with the laws of Malaysia.
